4. (/5) President Wilson's Fourteen Points document, which expressed American national interests, was intended to be a way to prevent more European conflict (to prevent or stop causes of war). By creating the League of Nations following the Fourteen Points, he hoped to invite Germany as an equal partner, rather than harshly punish Germany. Would Wilson have had success in convincing the Allies to adopt the Fourteen points?	
 (/5) Independent Canadian involvement in the Paris Peace Conference satisfied Canada's national interests*** because it was a just reward for Canadian accomplishments during WWI. ***What were Canada's national interests? How did Canada's involvement in the Paris Peace Conference satisfy these interests?
