Answer the following 5W and H questions (Who, What, When, Where, Why, and How) using a historian's eye.

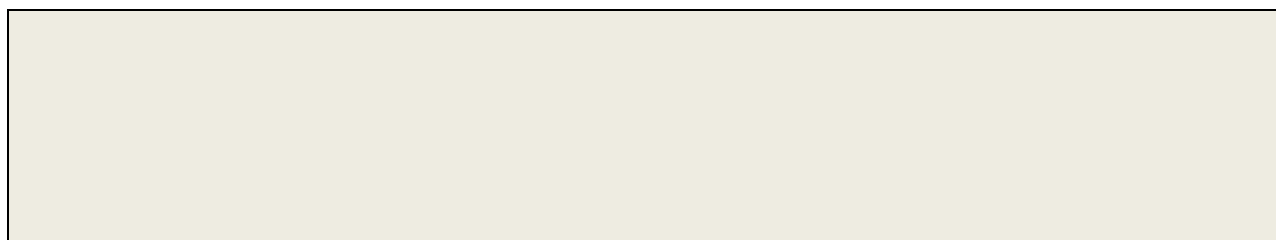
If you know a lot about the object, answer in complete sentences below. If it is an object you need to learn about, interview someone in your family about it, using the questions below.
