Key for Personal Response Essay

Students should consider details from the novel as they respond to the following questions:

- What did Gantos believe about his involvement in smuggling?
 Gantos wondered more than once whether he was doing something wrong, which demonstrates that his conscience bothered him. He used drugs and alcohol to quiet his doubts about his behavior. He chose to focus on the promises of his accomplices (\$10 000) and his desire to enroll in a college writing course to explain his wrong-doing.
- What led him to conclude "I'm not doing anything wrong"?

 Gantos adopted an "everybody's doing it" attitude, which seemed to make it right
 (Everybody around him Rik, Hamilton, others used drugs and alcohol and engaged
 in illegal behavior.). However, keeping his activities a secret from his father is a strong
 indication that he knew what he was doing was wrong. Society has laws about behavior
 that, indeed, make certain actions wrong. Gantos was not being truthful with himself
 because he feared punishment; people who live justly are rarely punished.
- What did he become because of his involvement in smuggling?

 Gantos had many negative and a few positive consequences of his smuggling experience.

 He was caught by the FBI and became a prisoner for over a year. His imprisonment brought shame and disappointment to his family. He became aware of inhumane behavior of individuals in prison and did whatever he could to avoid those people. His experience traumatized him, evidenced by his waking in the middle of the night anxious and fearful. His incarceration did enable him to address his addictions and to stay still long enough to pursue his goal of a career in writing.

Student support from personal experience will vary.
